



ISO 14001:2015 is the international standard for environmental management, it specifies the requirements for an effective environmental management system or EMS

ISO 14001 helps organizations make their day to day operations more sustainable through effective environmental risk controls.

Being more sustainable means that environmental impacts are reduced increasing sustainability through reduced product life cycle impacts, reduced energy and resource consumption as well as reduced levels of pollution.

What is an ISO 14001 EMS?

An environmental management system establishes risk controls designed to reduce an organization's environmental impacts covering everything from day-to-day operations to product lifecycle considerations.

The ISO 14001 standard covers the environmental aspects of an organization within your scoped EMS boundary and activities that can be controlled and influenced relating controls to regulatory requirements as appropriate.

ISO 14001:2015 follows Annex SL, the higher level structure for ISO management systems making it easier to integrate with other standards such as ISO 9001, ISO 45001 etc. It follows a 'Plan-Do-Check-Act' approach together with a clearer focus on environmental leadership, risk management, meaningful environmental objectives and the measurement of environmental performance.
